Dogs causing a disturbance to other dogs will be asked to leave building

General Informaton

- Dogs must be one year of age or older on the day of the test.
- Order of running Fast CAT's will be at the discretion of the field committee,
- Typically on an "is ready and waiting" basis. Priority for field committee dogs running to make the members of the committee available to run the test.
- The field committee reserves the right to bar known aggressive dogs from the event site.
- There will be a \$5 fine assessed for any loose dog not taking part in the course, or for anybody not picking up after their dog or leaving garbage on the field. \$5.00 fee to any dog who soils the test running area payable to the person who cleans it up.
- NO ONE will be allowed on the FAST CAT running field without the express permission of the Field Chairman, except the appointed field committee.
- Anybody exhibiting unsportsmanlike behavior will be excused from the field and may be subject to further disciplinary action with no refund of entries.
- Control of dogs strictly enforced, on leash at all times except when running.
- Clean up and dispose of all trash.
- Please pick up all dog feces and remove with trash or put in receptacle provided at site.
- This trial will be held under the AKC rules and regulations for lure coursing. Exhibitors are expected to be familiar with these rules.
- Participants who leave dogs, equipment and personal belongings unattended do so at their own risk. The show giving club and the owner of the site will not be responsible for dogs, equipment or personal belongings, nor for the loss of or damage to or death of any dog, whether the result of accident or any other cause.
- Participants shall be governed by any rules and regulations of civil authorities and/or location restrictions. Please obey all posted signs.
- Parents and guardians must be responsible for children. Children must be kept under the supervision of an adult at all times.
- Vehicles will be allowed to park in designated areas only.
- Returned checks do not constitute a valid entry. A collection fee will be added to the amount of each returned check.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy or any other causes beyond the control of the club.

A light blue qualifying ribbon will be given for each qualifying run. Rosettes will be given for new titles

Practice Runs

Will be held Saturday only, if weather, equipment and daylight permit. Practice is \$5.00per dog/run.

Practice will NOT be offered on Sunday
